# **CECA Wales Monday Briefing**

### Current workload trends in the civils sector

Last week we published our workload trends survey (which many of you contribute to) for the first quarter of 2023. The overriding message was "declining workloads in the roads and preliminary works sectors could spell trouble for the UK's economy". I have attached the survey report with this briefing.

Results from the survey found that while the civils sector experienced a tenth quarter of growth in 2023 Q1, nonetheless falling workloads in the roads sector and in preliminary works for housing - traditional bellwethers for civil engineering activity - should concern policy and decision makers. In addition, cost pressures remain elevated for civils firms, with 81 per cent of companies reporting increases of over 5 per cent, while the supply of skilled operatives remains one of the key supply issues facing contractors across England, Scotland and Wales.

CECA Chief Executive Alasdair Reisner said: "These statistics show that while the UK's infrastructure sector continues to act as the backbone of UK plc in delivering much-needed economic growth, there could be trouble ahead at a time when we need the industry to be firing on all cylinders. Infrastructure underpins every aspect of our lives and is a major employer in all parts of the country, which is why we are highlighting that these sectors are struggling due to challenges they are facing, not least rising inflation, supply chain disruption, and a loss of business confidence. If the UK Government wishes to see progress in meeting its housing ambitions and to deliver the connectivity businesses and communities need to thrive, it must work with industry to understand why bottlenecks are appearing in these sectors, and work to bring projects forward to market without delay."

From a Welsh perspective we've already seen reductions in road building investment (we've discussed this at length!) but there are some signs that investment in other areas could compensate (although that is in the medium to long term). Cost increases are still putting pressure on tender returns but the long standing issue on the availability of skilled operatives remains a huge challenge. With that in mind I am continuing to work with CITB Cymru, Colegau Cymru and a number of our members to address the shortage of training provision for operatives and I hope to be able to update you soon on opportunities for a funded skills programme for groundworkers which will hopefully offer a short term alternative to apprenticeship provision which continues to be difficult.

## **CECA Wales Political Update**

Infrastructure matters to note from both the Senedd and Westminster include:

- The First Minister responded to questions from Rhianon Passmore MS and Laura Anne Jones MS on the challenges facing the construction industry, reversing the decline in Welsh construction output and attracting more people into the sector.
- Adam Price MS requested an update from the First Minister on the Welsh Government's commitment in the last Senedd to introduce a Llandeilo bypass.
- Adam Price MS also asked the Welsh Government to commission an independent study on undergrounding and called for the development of a national plan for the electricity grid.
- During this week's Business Statement and Announcement, Mike Hedges MS asked for an update on the Swansea Bay and West Wales metro, while Mark Isherwood MS called for statement on the Wrexham to Bidston rail line. Menai Bridge: Rhun ap lorweth MS asked the Trefnydd for a statement on the need to reset hangars on the Menai Bridge.
- The Department for Transport and National Highways have published a public consultation on National Highways' strategic road network (England) Initial Report.
- National Highways have published the following documents aimed at work in England:
  - o Environmental Sustainability Strategy, entitled 'National Highways Environmental Sustainability Strategy'
  - o Strategic Road Network Initial Report, entitled 'National Highways Strategic Road Network Initial Report'
  - o 'Connecting the Country: our long-term strategic plan'.
- The Department for Transport has announced £200m in funding for cycling and walking schemes, helping to promote healthy travel, reduce emissions and grow the economy.
